Per regulation, trucks <u>MUST</u> have a current fire extinguisher. Ensure to send your required docs in as noted <u>here</u> .

SALES	or set-up shall t	ns being sold or displayed MUST be contained in the space purchased. No items, solicitation, up shall take place outside the purchased space. Prices of food items must be clearly red along with methods of payment accepted.					
	Attendance Averages: 500 sustained event attendance / ~1200-1500 throughout event duration						
WEATHER	The event <b>will not</b> be canceled because of rain. This is an outdoor event; be prepared for any type of weather. If approved tents, tables, canopies and pop-ups are part of your food truck apparatus, they must be secured to withstand the elements.						
REQUIREMENTS	The exhibitor is responsible to be open for the entire event. You cannot vacate early. For further confirmation, contact a MASS District Events representative.
